2. The per diem reimbursement rate shall be in accordance with the New York State Reimbursement Rate (http://www.osc.state.ny.us/agencies/travel/reimbrate.htm) – New York State uses the per diem rates established by the Federal Government.

3. The following Travel Forms will be utilized for all travel claims and reimbursements: AC132-S (Effective 4/12), AC160-S (Effective 1/12), and AC3259-S (Effective 1/12). When Traveling 100 miles or more per trip claimant must complete the Personal Car at Rental Rate Calculator and attach to expense report.

### **Investment Policy for Colden Fire District**

1. This investment policy applies to all moneys and other financial resources available for investment on its own behalf.

2. The primary objectives of this fire district's investment activities are, in priority order:

- To conform with all applicable federal, state and other legal requirements;
- To adequately safeguard principal;
- To provide sufficient liquidity to meet all operating requirements; and
- To obtain a reasonable rate of return.

3. The Board of Fire Commissioners' responsibility for administration of the investment program is delegated to the Fire District Treasurer.

4. The fire district treasurer shall act responsibly as custodian of the public trust and shall avoid any transaction that might impair public confidence in the Colden Fire District. Investments shall be made with judgment and care, under circumstances then prevailing, which persons of prudence, discretion and intelligence exercise in the management of their own affairs, not for speculation, but for investment, considering the safety of the principal as well as the probable income to be derived.

The Fire District Treasurer shall refrain from personal business activity that could conflict with proper execution of the investment program, or which could impair his or her ability to make impartial investment decisions.

5. It is the policy of the Colden Fire District to diversify its deposits and investments by financial institution, by investment instrument and by mature scheduling.

It is the policy of the Colden Fire District for all funds coming into the hands of the fire district treasurer to be deposited or invested within five days of receipt.

The banks and trust companies authorized for the deposit of moneys up to the maximum amount in any account are:

Depository Name	Maximum Amount

6. Eligible securities used for collateralizing deposits shall be held by the depository named by the Board of Fire Commissioners subject to security and custodial agreements, all in accord with the applicable provisions of General Municipal Law Section 10.

7. The Board of Fire Commissioners of the Colden Fire District authorizes the fire district treasurer to invest moneys not required for immediate expenditure for terms not to exceed its projected cash flow needs in the following types of investments:

- a. Special time deposit accounts;
- b. Certificates of Deposit;
- c. Obligations of the United States of America;

d. Obligations guaranteed by agencies of the United States of America where the payment of principal and interest are guaranteed by the United States of America;

e. Obligations of the State of New York; and

f. Obligations issued by a municipality, school district or fire district other than the Colden Fire District

8. The Board authorizes the use of electronic monthly statements to prevent from paying bank fees when they apply

All investment obligations shall be payable or redeemable at the option of the Colden Fire District within such times as the proceeds for which the moneys were provided and, in the case of obligations purchased with the proceeds of bonds or notes, shall be payable or redeemable at the option of the Colden Fire District within 2 years of the date of purchase.

A vote was taken on January 2, 2025 and the motion to sanctioned Calendar Year 2024 expenditures was approved

BE IT RESOLVED that the Fire District Treasurer will submit to the Board of Fire Commissioners a copy of the annual report required by General Municipal Law Section 30 within the next sixty days.

#### 26. Resolution # 2025- 021 – Fire District Committee Appointments

Commissioner Abraham made a motion to approve all committee appointments for the Colden Fire District and Commissioner Marinaccio seconded the motion. Abraham-Yea, Shelley-Yea, Jarecki-Yea, Smith-Yea, Marinaccio-Yea Motion Approved

A vote was taken and the motion to approve all committee appointments for the Colden Fire District was approved.

NOW THEREFORE, be it RESOLVED by the Commissioners of Colden Fire District, in the Town of Colden, County of Erie, the following appointments are as follows:

 <u>Personnel, Insurance and Service Award Committee</u> - The Board's standing Personnel, Insurance and Service Award Committee shall be concerned with the functions, activities, operations, compensation, Worker Compensation Claims, negotiations, and membership applications from Fire Company, and the welfare of District personnel.

Primary: Commissioner Jarecki, Alternate: Commissioner Marinaccio

\*Active Status is when a firefighter attends calls that meet LOSAP Standards and completes all mandatory training requirements (i.e. OSHA, etc.)

\*If an Active Firefighter is in default of the minimum requirements for maintaining an active membership, they will be notified by the Fire Chief. Member will be placed in a remediation status and a supervision program will be established by the Fire Chief for that member. Loss of active status will result if the member defaults in the remedial program.

\*All injuries will be reported to the Board of Fire Commissioners immediately and on a monthly basis whether or not there were any injuries. Fire Chief will prepare an Incident Report for each injury and submit to the Fire District.

This Committee shall be concerned with the insurance coverage of the Fire District and its employees. The District shall carry all types of insurance to prevent losses due to adverse judgments for death or personal injury and damage or destruction of District property, or property of others, by fire or other casualty. The Committee shall also be concerned with maintaining and manage the Service Award Program and shall coordinate all contributions to the service provider. \*January 1st to December 31st will be the yearly dates for maintaining the attendance records for the Service Award Program.

\*Entitlement to the Service Award Program is when a firefighter achieves 50 points and meets the minimum requirements of §217 General Municipal Law.

 <u>Maintenance of Buildings, Apparatus, Driver Certification,</u> <u>Communications, Committee</u> – The Board's standing Committee shall be concerned with the maintenance of fire fighter equipment and driver selection and testing that will ensure that only the safest drivers operate District equipment. This Committee will also be concerned with the planning of facilities, facility repairs, acquisition of new fire apparatus and equipment to protect the Fire District.

Primary: Commissioner Shelley, Alternate: Commissioner Abraham

Fire Apparatus (1, 2, 3, 5, 7 and 8) - Fire District Driving Certification Official is Commissioner Shelley – All personnel will be tested on an annual basis.

 <u>Executive Board Committee</u> – The Board's standing Executive Board Committee shall be concerned with acting as a liaison between the Fire Company and the Fire Board. Committee will attend all meetings of the Executive Board of the Fire Company.

Primary: Commissioner Marinaccio

 <u>Training Committee</u> – The Board's standing Training Committee shall be concerned with the readiness of firefighters and EMS personnel. Ensure that all mandatory training is scheduled and conducted. Provides assistance to the Fire Chief when requested.

Primary: Commissioner Smith, Alternate: Commissioner Shelley, Colden 9 & Colden 9-1

 <u>Standard Operating Guideline (SOG)</u> – Review, Maintain and present updates to the District as necessary all established Standard Operating Guidelines.

Primary: Commissioner Jarecki, Alternate: Commissioner Smith

 <u>Medical Readiness</u> - The Board's standing Medical Readiness Committee shall be concerned with maintaining medical records in accordance with Privacy and Security of Health Information Program of New York State (HIPPA) and SOG # II-03 – Medical Surveillance Program. Ensuring that all active personnel have a current physical and that all physicals are within a 12 month period. Primary: Commissioner Smith, Alternate: Colden 9-3

• <u>Appointment of Privacy Officer</u>: The Privacy Officer is needed to oversee the Privacy SOG and monitor the PCR filing program.

Primary: Commissioner Smith, Alternates: Colden 9-3 and Douglas Hyde
